
PHYSICAL EDUCATION DEPARTMENT:

Talents day was organised on November 16th 2016. It provided an opportunity to the students to exhibit their talent in various arts.



SPORTS REPORT


Ladies and Gentlemen:

HOMAGE:



During this academic year from 5th to 7th April 2019 Advocate P.Shivaji Shetty Memorial fourth National Moot Court competition was conducted with the whole hearted support of Mrs. Jayanthi Shivaji Shetty and Alumni Association of our college. 28 teams participated from across the country.

The competition was inaugurated by Prof.(Dr.)T.R.Subramanya, Former Vice Chancellor, KSLU Hubballi, Dean, School of legal Studies CMR University, Bengaluru. The function was presided over by Honorable Mr.C.M.Joshi, Principal District and Sessions Judge, Udupi.
