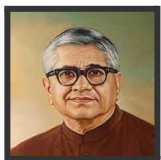

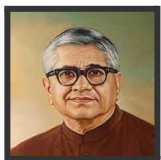

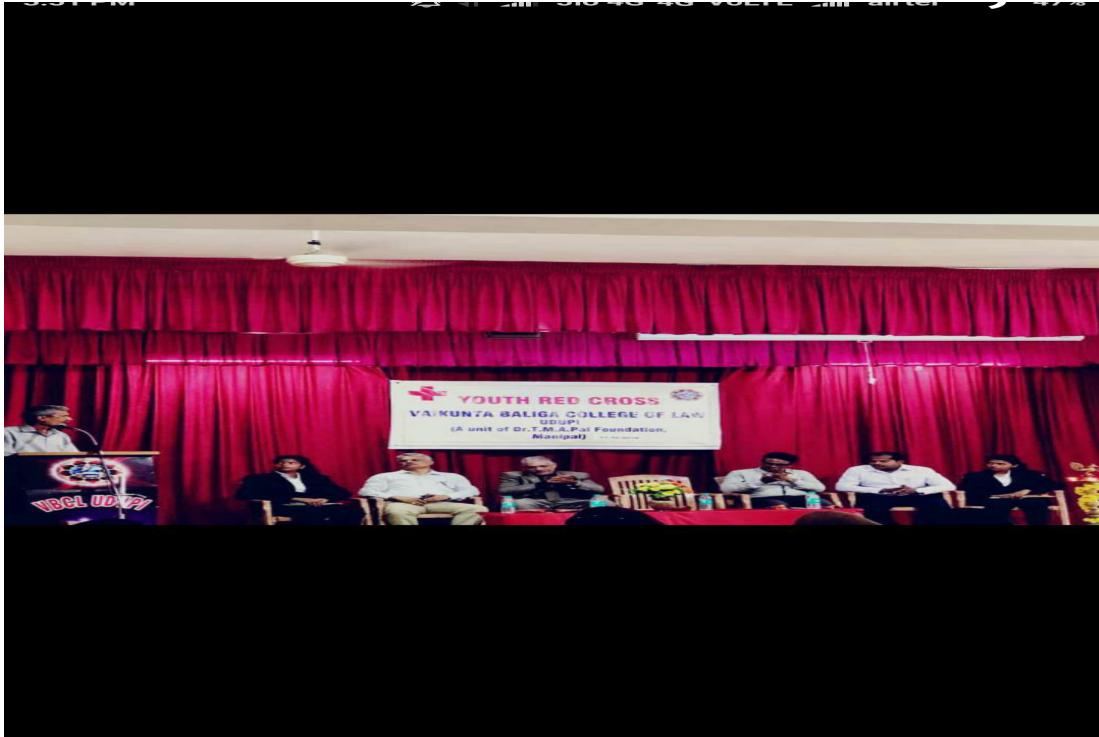
TALENTS DAY 2018

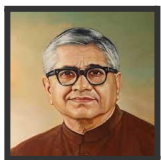
